1. Pursuant to the Agreement and Plan of Merger dated July 21, 2007 (the "Merger Agreement") among Transocean Inc. ("Transocean"), Transocean Worldwide Inc. and GlobalSantaFe Corporation ("GlobalSantaFe"), at the effective time of the merger contemplated by the Merger Agreement (the "Merger"), each outstanding ordinary share, par value \$0.01 per share of GlobalSantaFe, was converted into the right to receive 0.4757 ordinary shares of Transocean, having a market value of \$129.39 per share as of the close of trading on the trading day immediately preceding the effective time of the Merger and \$22.46 in cash. At the effective time of the Merger, the reporting person held shares of GlobalSantaFe in a joint account with his wife that were converted into the right to receive 126 shares of Transocean. **Remarks:**
